

# **ARTICLES OF INCORPORATION**

OF

# SMALL BUSINESS INVESTMENT CORPORATION

The undersigned, acting as an Incorporator of a corporation under the New Mexico Nonprofit Corporation Act and created pursuant to Section 58-29-4 NMSA 1978, made effective on May 17, 2000, by and through the New Mexico Constitution, Article IV, Section 23, adopts the following Articles of Incorporation for the corporation:

# **ARTICLE I**

Its corporate name will be Small Business Investment Corporation.

#### **ARTICLE II**

Its period of duration will be perpetual.

# **ARTICLE III**

It is organized and will be operated exclusively for purposes of creating new job opportunities by making equity investments in land, buildings or infrastructure for facilities to support new or expanding businesses in the State of New Mexico, and will not carry on any activity not permitted to be carried on by, or which would jeopardize the tax exempt status of, an organization exempt under Section 501(c)(4) of the Internal Revenue Code and its Regulations, as they now or hereafter exist.

#### **ARTICLE IV**

It may exercise only those powers which are in furtherance of its tax exempt purposes and activities, and which may be exercised by an organization exempt under Section 501(c)(4) of the Internal Revenue Code and its regulations, as they now or hereafter exist.

# **ARTICLE V**

It does not afford pecuniary gain, incidentally or otherwise, to its members. No part of the income, profit, or net earnings of the corporation will inure to the benefit of, or be distributable to, the members, directors, or officers of the corporation, or other private persons, except that the corporation may pay reasonable compensation for services rendered, and may make distributions in furtherance of its corporate purposes either directly, or by contributing to the State of New Mexico severance tax permanent fund. Upon dissolution, the corporate assets will be distributed first in payment of all liabilities of the corporation, then exclusively for the purposes of the corporation, and then to the State of New Mexico severance tax permanent fund.

#### **ARTICLE VI**

Its initial registered office address will be 6565 Americas Parkway, N.E., Suite 1000, Albuquerque, New Mexico 87110 and its initial registered agent at that address will be David P. Buchholtz.

#### **ARTICLE VII**


